**RULES OF PARTICIPATION**

1. Protective masks are obligatorily to be put on, prior to a player entering the activity field and should by no means be allowed to be removed anytime throughout gaming and until after the participant has left the activity field. The only zone within which participants may remove their face protective gear is the waiting area.
2. It is strictly forbidden to take paint guns (i.e. paintball tools) outside the gaming zone or otherwise use such instruments outside the activity field. Paint guns shall have to have their safety tap or sleeve on at all times; such safety taps or sleeves will be expected to be on whenever so is required.
3. Players shall be expected to conform to the instructions of referees and judges at all times. No physical contact between players or between any single player and any other player's gear, during the game is permitted.
4. Moving the artificial hurdles within the gaming zone (i.e. vehicles, tyres, pallets, reels, barrels ea.), climbing onto or into any of such objects are not allowed. Paint balls having eventually fallen down or for any reason happening to lie on the ground of the field may not be picked up.
5. It is strictly prohibited to consume alcohol or any hallucinogen substances, whether immediately prior to or during any gaming session.

**TERMS AND CONDITIONS**

Strict adherence to the rules set forth above has contributed to making Paintball one of the safest and less injury-hazardous team games, according to statistics. As with any sporting or gaming activity, however, the risk for injury or even loss of life, particularly in the case of persons having health issues (e.g. heart conditions) or in the event of negligence in applying said rules as well as under various other circumstances, may not be altogether excluded. In the event of the officers in charge of the activity (referees, judges, agents or the proprietors of the premises) estimating that a person wishing to engage in such gaming activities is suffering from a pronouncedly limited degree of accountability – meaning such person is likely not to be in a position to realize the eventual unlawfulness of one's actions or is, (as a consequence of one's being under the influence of alcohol or illegal substances or of one's problematic mental or emotional condition), likely to act on an altered perception of righteousness, said officers shall be entitled to deny such persons access to any of the activities on the premises. *Afantou Paintball* having seen to the adoption of all necessary safety measures, we decline any liability for any accidents eventually to occur to players failing to abide with safety rules as well as for any other occurrence to players, resulting from failure by the latter to previously disclose any health issues.

Players found to be in breach of any of the provisions under the rules, terms and conditions herein shall be promptly banned from the gaming field.

**Upon carefully reading through all of the above, I hereby AGREE TO and ENDORSE the following :**

1. I fully understand the risks – whether known or not – implied by my participation in this activity, including those hazards eventually resulting from negligence by any of my co-players rather than by myself.
2. I anticipate the likelihood of paintballing becoming physically and/or emotionally strenuous and do acknowledge my obligation to immediately alert the first available officer of any discomfort I may feel or of any risk I may at any time feel my health is at.
3. I hereby hold *Afantou Paintball* (including referees, judges, agents and proprietors of the premises) free from any liability for any accidents likely to occur as a consequence of negligence of myself or of any other player or for any other circumstances attributable to me or imputable upon any other participant.
4. These being activities carried out into the open, I understand that engaging in them implies such risks as may normally apply when it comes to outdoorings (namely moving about on uneven grounds, the likelihood of insects or reptiles being around, ea.), which risks I also accept.
5. I understand the present statement to apply with respect to any activity in which I am likely to engage, until after I have withdrawn myself from the field. Lastly and in order to be allowed participation, **I hereby solemnly and consciously DECLARE:**
  - To be in full command of my actions, free as I am of any mental or physical condition or any other health issue whatsoever, such as to render my participation in the game inadvisable.
  - To have been sufficiently brought up to date by the officer in charge and have, as a consequence thereof, come to be fully acquainted with all the rules governing the particular activity, to the totality of which I hereby unreservedly subscribe.
  - I allow *Afantou Paintball* to make use of my personal details during my dwelling into the premises, albeit solely for marketing and/or promotional purposes, also warranting to have read through, become acquainted with and willingly endorse the contents herein, in witness whereof I have provided my signature, below.
  - In addition to the above, in the event of a parent/guardian of one or several, underage players I hereby solemnly declare that although minors, each one and all of such underage players in my custody are above 13 years of age as well as that I hereby undertake full responsibility for their actions in connection with their participation in any activity within the premises.
